


Installation Instructions: Free Wheeling Hubs




 Remove dust cap, snap ring, drive flange, spring and oil slinger (or old hub lock unit). Check ball joint, king pin, axle housing/spindle/bearings condition.
Shafts must float freely in all directions.



 Separate Superwinch hub assemblies (body assembly/Clutch assembly).



 Insert Superwinch body assembly into wheel hub and install internal snap ring. Install Superwinch special snap ring on axle shaft. (DO NOT USE ORIGINAL SNAP RING).




 Install clutch assembly. Cross torque cover screws to 26-35 in. lb. (30-40 kgf. cm).

Operation:

2-Wheel Drive (4x2 or Free) – Turn the control dial counterclockwise – using fingers only – to the 4x2 position. The front wheels are now completely disengaged from the transmission. 4-Wheel Drive (4x4 or Lock) – Turn the control dial clockwise – using fingers only – to the 4x4 position. The front drive now operates precisely as before the free wheel hubs were installed.

Maintenance:


None required. Superwinch Free-Wheeling Hubs are permanently lubricated. If unit is disassembled for inspection, DO NOT USE GREASE. Lubricate lightly with SAE 30 oil. IMPORTANT: Every time hubs are disassembled for vehicle maintenance, make sure parts supplied in Superwinch service kit are used for re-installation.






LIMITED WARRANTY

Any Product that Superwinch determines to be defective will be repaired or replaced at Superwinch's sole discretion without charge to Buyer upon Buyer's compliance with these procedures. Seller or its Authorized Agent may make reasonable charges for parts and labor for repairs not covered by this Limited Warranty. The warranties set forth herein are exclusive and in lieu of all other warranties, whether oral or written, express or implied.

LIMITED WARRANTY PROCEDURE

When contacting Seller, Buyer shall mail, ship or otherwise deliver to Seller at the address noted below (1) the Product; (2) a written description of the problem; (3) Buyer's name, address and telephone number; and (4) a copy of the original sales receipt. Mail, ship or otherwise deliver the Product, required information and copies to Seller, postage or shipping prepaid. LIMITATIONS AND EXCLUSIONS

This warranty does not apply to defects in any Product caused by: (1) normal wear and tear; (2) failure to comply with any installation, operation or maintenance instructions provided by Superwinch including but not limited to use of grease or subjecting the Product to loads in excess of the load listed in the Owner's Manual or instructions for the particular Product and model number; (3) commercial or industrial use; (4) alteration or modification by parties other than Superwinch; (5) misuse, abuse, neglect, accident, Acts of God or terrorism; or (6) other causes beyond the control of Superwinch after delivery of the Product by Superwinch to its authorized distributor. If any model or sample was shown to Buyer, such model or sample was used for illustrative purposes only and shall not be construed as a warranty that the Product shall conform to the sample or model.
